### **How to Find Out if Your Business Exists with the IRS ...**

State registration is necessary if you are "doing business" in a state. The definition of "doing business" is different for income tax and for sales taxes; this article describes the requirements for each. If you need to register in another state for income tax purposes, you will need to register as a "foreign" entity (a foreign LLC, for example).

### **Register Your Business With U.S. Government Entities**

Withholding Tax - If you employ one or more employees in your business, you may be required to register with DRS to withhold Connecticut income tax. Business Entity Tax - If you are a domestic or foreign entity such as (S-corp, LLP, Limited partnership, LLC) and/or are required to register or file a certificate of authority with the Secretary ...

Generally, if you have business activity in the Commonwealth of Virginia, you need to register your business with Virginia Tax. New Businesses. Before registering with us, most new businesses will need to get a federal Employer Identification Number (EIN) from the IRS, and some will need to

register with the State Corporation Commission.
